My name is Gary Onopa I am 19 years of age and live at the above mentioned address with my mother. On February 2, 1980 I went to the Starburst lounge located at 5030 Fairbanks in company of two other friends Allen and Jim. We got to the bar at about 10:30 P.M. and we were just drinking beer and playing pool. During the time we were at the bar there was not trouble as far as I know. The waitress came by and said it was time for last call as it was closing time. I finished my beer and handed her my glass. We were just about to start our last game of pool, when I heard a popping noise it sounded like fire crackers. There were several popping sounds I do not know just how many but there was a lot. All this time I was standing by the pool table facing towards the front door. I looked up and saw a man standing by the front door and he was holding a rifle. The rifle appear to be a 22 caliber rifle. When I first saw the man with the rifle he was still shooting. There is a section of the bar where people come up to get their beer and when the man was shooting three persons fell to the floor in that section of the bar I know for ~~sure~~ sure that one was a man and one was a woman I am not sure on the third as they all fell kind of on top of each other. and there was another man by the pool tables. All this for persons appeared to be dead to me, there were several others persons that were shot and they were in different sections of the bar. When the man pointed the rifle in my direction and fire I ducked behind the pool table, When the shooting stopped I went over to where the man that had been doing the shooting was but when I got there they had him under control and he was sitting down. I then started to assist some of the injured people in the bar that had been shot. When I saw the man that had been doing the shooting I know I have seen him around but I do not know him by name. The man that was doing the shooting was a white male about 30 5' slim long straight hair, wearing a Red jacket and I believe he was wearing blue jeans. A short time after that the police arrived and placed the man under arrest and then the injured were taken to the hospital.
